Bills, including sponsors, amendments, action and history can be found by clicking on the bill number. In the bill page, scroll down and click on the last item under "Bill Documents". You can view a shorter bill analysis under "Bill Reports". Again, the last item relates to the bill in its current status.

February 23 is the House Policy Committees cutoff. February 25 is the House Appropriations committees deadline. February 26 is the cutoff for House Bills to be out of the Senate policy committee in the opposite house. The bills in Bill Watch are still moving.
