## **WASA Recognizes Exemplary Educational Leaders at the 2015 WASA/AWSP Summer Conference**

*Washington state educators celebrate successes, focus on skills to “Lead Proceed Succeed.”*

**SPOKANE** — Over 800 school superintendents, central office administrators, and principals from across Washington state gathered in Spokane to attend the 35th annual Washington Association of School Administrators (WASA) and Association of Washington School Principals (AWSP) Summer Conference. The theme of this year’s conference, “Lead Proceed Succeed,” focused on helping leaders grow and succeed in leading their schools, districts, and staffs.

In addition to 64 breakout sessions on topics that include leadership, culture, student support, data/technology, early learning, graduation/college and career ready, and safety/crisis/preparedness, the event also played host to WASA’s 2015 Honorary Awards Luncheon where WASA state level awards, the Robert J. Handy Most Effective Administrative awards, and the Dr. Doyle E. Winter Scholarship for Administrative Leadership in Education were presented. Those receiving special recognition this year included:

### **Robert J. Handy Most Effective Administrator Awards**

The Robert J. Handy Most Effective Administrator Awards, sponsored by PEMCO Insurance and WASA, seek to recognize outstanding public school administrators in Washington state. One highly effective superintendent, central office administrator, or building administrator is selected from a small school district (up to 500 students), medium-sized school district (501–2,000 students), and large school district (over 2,000 students). A \$10,000 award is equally divided among the three winners. A peer committee selects the recipients from nominations that describe how each nominee is taking part in realizing the nine characteristics of high performing schools/districts as defined by research from the Office of Superintendent of Public Instruction.

### **Dr. Doyle E. Winter Scholarship for Administrative Leadership in Education**

The 2015 Dr. Doyle E. Winter Scholarship for Administrative Leadership in Education was presented to Brian Hart, executive director of curriculum, instruction, and assessment from Sunnyside School District. The \$1,000 scholarship is cosponsored by Piper Jaffray & Company, Seattle-Northwest Division and WASA. Hart was selected for his work to “develop a first-class professional development model that supports every teacher in helping each student make standard and graduate with career and college readiness skills.”

The Doyle E. Winter Scholarship is designed to assist talented and committed educational administrators as they enhance those skills needed to serve as educational leaders in the field of public education. The scholarship was established in honor of Dr. Doyle Winter, who retired in 2002 after completing 44 years of service for Washington public schools. Winter is a former executive director of WASA and has been recognized repeatedly for exhibiting exemplary leadership ability and enhancing school administration throughout his career.
